Review Unaudited Financial Statements

Ms. Wheeler reviewed the September 30, 2022 unaudited financials with the Board of District Nos. 1 & 2. Following discussion, upon a motion duly made and seconded, the Boards unanimously accepted the financials.

Review and Approve Claims Listing

Ms. Wheeler reviewed the claims in the amount of \$81,522.73 with the Boards. Following discussion, upon a motion duly made and seconded, the Boards unanimously approved the claims listing.

Consider Approval Resolution Adopting 2023 Budgets

of Ms. Wheeler presented the 2023 mill levies to the Boards noting the that the adjustment based on the assessed valuation that was done historically is changing and if the underlying land is not assessed as residential, the method of adjusting the mill levy will be different. Following discussion, upon a motion duly made and seconded, the Boards unanimously adopted the resolution adopting the 2023 Budget, appropriating funds therefor and certifying mills as shown in the 2023 Budget, subject to receipt of final assessed valuation.

Other Financial Matters

Director Fellows noted that sales in the community have slowed down and as a result property tax revenue and fees to the Districts decreased.

Discussion Cancellation of The Boards engaged in general discussion regarding the Regular cancellation of the December 22<sup>nd</sup> regular meeting. Following discussion, upon a motion duly made and seconded, the Boards unanimously cancelled the meeting.
