Pursuant to HB24-1454, § 24-85-103(2.5), C.R.S., and 8 CCR 1501-11 Governor’s Office of Information Technology Rules Establishing Technology Accessibility Standards (the “Rules”), Painted Prairie Metropolitan District Nos. 1-12 and Painted Prairie Business Improvement District Nos. 1&2 (collectively the “Districts”) are required to provide a progress-to-date report that demonstrates concrete and specific efforts toward compliance.
